Dear Mr. Hough:

This letter is to follow up on the status of the remedial work done pursuant to the Settlement Agreement entered into between our clients. There are a number of open issues that need to be addressed to close out the work. This letter does not address the issue of the increased insurance premiums which we previously discussed. As we discussed, it is the Association's position that the insurance issues are latent and such latent issues were not part of the release of the Settlement Agreement and are the result of original defective construction or design.

### **Damaged Items During Construction**

During the course of construction some areas of the property were damaged. We do not believe any of these were done maliciously but the fact is that damage did occur. The areas at issue include sidewalks/gutters, grading issues, sprinkler heads and irrigation wiring. With regard to the sidewalks/gutters, it is my understanding that these areas have been observed with Dueall Construction and there has been some identification as to areas that need to be addressed. However, a concern that the Association had is that it is difficult to tell which areas were cracked as a result of damage and which areas were originally constructed improperly. Since the damage would fall into either category and would be the responsibility of KB Homes, the Association requests that all damaged sidewalks and gutters be repaired.

With regard to the grading issues, the work done damaged the grading to some level at various parts of the property. A site inspection with the parties would be agreeable to identify the areas of grading that need to be addressed. Alternatively we can provide you with a list of these areas.

Also, there are sprinkler heads that have been damaged during the course of construction while workers were walking on the grass or bringing equipment through those areas. My understanding is that it will cost approximately \$5,900 to replace the damaged sprinkler heads.

Also, the landscapers are currently replacing hundreds of feet of irrigation wiring which has been nicked or cut during the remediation.

### **Screen Enclosures**

As you are aware the Settlement Agreement set forth a cost for the replacement of screen enclosures. The costs varied depending on the location of the enclosure. As you know, the Association had been paying for the screen enclosures with your client reimbursing those costs. Unfortunately, this meant that unlike the rest of the construction the Association was put in the position of coordinating the work and paying those costs up front. It is my understanding from that during the course of construction that it became clear that the costs were increased by the vendor for the screen enclosures. My further understanding is that this information was conveyed to your client and that everyone was aware of the increased costs. Unfortunately, this has resulted in approximately \$75,000 of increased screen enclosure costs for which the Association has not been reimbursed. I have attached to my letter a spreadsheet outlining the specific screen enclosures that were done and to which the increased costs applied.

### **Interior Unit Closeouts**

As you are aware, your client sent letters to unit owners so as to coordinate and perform interior repairs. The letters provided 7 days to respond or otherwise purported that KB Homes would not address the unit or interiors. My understanding is that there are 50 units similarly situated. The problem is that many of these owners received the letters after the 7 days had expired. Others have not responded. This is an open issue and the project cannot be closed out with unit owners who want interior repairs and cannot get them done. To that extent, we would like KB Homes to make it clear that all owners to whom these letters have been sent but who have not yet responded may still do so within a more reasonable timeframe to have those repairs done. Although these repairs are to the unit interiors it is in both of our clients' best interests to get this work done. I do not have the full list of the units affected in this matter but I understand that our clients do. I would suggest going through those lists and making additional efforts to sit down with all of the affected owners to resolve these issues within a reasonable time frame. Also, several residents have complained to the board of not knowing who to contact at KB to address items they are unhappy about. Please let us know to whom these owners should be directed.

### **Party Wall Issues**

It is my understanding that based upon observations made of the party wall on Monday that the existing strapping, in at least one unit, does not match the strapping on the plans. However, it is my further understanding that Thomas Miller, P.E., advised that the deviation from the plans was previously accepted and that his calculations showed that there was no structural issue as a result of the missing strapping. I understand that Mr. Miller is performing some additional calculations and will issue a report advising of his results. I do not have a timeframe within which he would provide this report so I would ask that you follow up with him as soon as possible.

### **Mold Clearance**

It is my understanding that at some point unit owners were receiving clearance for mold from AMRC as to their individual units. At some point, KB Homes stopped allowing AMRC to issue the clearances. It is my understanding that the reason they stopped issuing mold clearances was because of language in the reports referencing limitations as it pertained to the air conditioning ducts and that AMRC could not sign off that the units were free of mold due to the ducts. However, based on our conversations it is my understanding that AMRC has cleared the repaired areas and damaged wood of any mold issues. Please confirm exactly what AMRC is saying with regard to the mold remediation.



### **Karins**

We are reviewing the Karins invoices but there appear to be items that KB should have paid for but were paid for by the Association. We do not yet have a final number for this but should shortly. Also, I am reviewing Karins' list of outstanding items and may revise this list to include anything not included.

### **Miscellaneous**

- There appear to be multiple buildings that are not grounded on the exterior. This is an issue as multiple residents have blackouts/ surges. 
- Multiple trees taken down for construction-needs to be replaced
- New sod is needed in multiple areas destroyed by construction or continued irrigation being shut off during construction.
- Multiple irrigation boxes still damaged.

We would like to get these issues resolved as soon as possible. As noted above, I will address the insurance issues separately. Please contact me should you have any questions.
